MOVANO GLOSSARY OF TERMS

PLATED WEIGHT

The maximum weight to which a vehicle or an axle may be loaded, determined either by the design of the components or by legislation. All commercial vehicles must carry a manufacturer's 'plate' showing the vehicle and axle gross 'plated weights'. It is an offence to drive a vehicle in a condition where any of these weights are exceeded.

KERBWEIGHT

The weight of the complete vehicle in standard form, excluding payload and driver but including coolant, oil, 90% full fuel tank and spare wheel where appropriate. Kerbweights quoted in Vauxhall brochures are subject to manufacturing tolerances and to the fitment of optional equipment and accessories. Where load capacity is critical the actual kerbweight should be obtained by weighing the vehicle on a calibrated public weighbridge.

GROSS VEHICLE WEIGHT (GVW)

The total permissible weight of a vehicle including payload and passengers, as shown on the manufacturer's plate.

GROSS COMBINATION WEIGHT (GCW)

The maximum permissible weight of a vehicle, including payload and passengers, combined with the total weight of any trailer it is towing. The maximum GCW weight limit is quoted on the vehicle plate and must not be exceeded.

PAYLOAD

The total permissible weight that can be carried without exceeding the vehicle's plated weight. This can be obtained by deducting the kerbweight from the plated Gross Vehicle Weight (GVW). Please note: the payload figure does not allow for the weight of the driver or any passengers.

MAXIMUM TOWING WEIGHT

The maximum weight of any trailer and its load which may be towed within the limit of the vehicle's plated Gross Combination Weight (GCW). It is based on the ability of the vehicle – at full GCW – to restart on a 12% gradient, which is approximately 1 in 8.3, at sea level. At altitudes above 1500 metres, the engine output may drop with a corresponding reduction in towing capability. It is the operator's responsibility to ensure that the trailer noseweight does not cause the rear axle plated weight of the towing vehicle to be exceeded.

Always fit Vauxhall towing attachments and accessories available from your Vauxhall Commercial Vehicle retailer. They are designed specifically for Vauxhall models and carry a 12-month warranty.

LIGHT DUTY AND HEAVY DUTY CYCLES

For a Light Duty cycle (EC regulation 715/2007 with designation "Euro 6") the emissions of the whole vehicle are evaluated whereas for Heavy Duty cycle (EC regulation 595/2009 with designation "Euro VI") only the engine is bench tested. The requirement of which cycle is necessary is determined by the reference mass of the vehicle. In the case of Movano, reference mass calculations dictate that:

- N1 FWD and M1 FWD are approved as Light Duty
- N1 RWD, N2 RWD and M2 FWD are approved as Heavy Duty

When Euro 5 was previously introduced, there was an agreement between Member States and the Commission (Reference TEC 740/2011) that, assuming there was no alteration to the emissions system itself, a multi-stage build vehicle should be covered by the base vehicle emissions approval, irrespective of whether the reference mass had changed. The Department for Transport has confirmed that this interpretation will remain in place for Euro 6/VI.

To illustrate this better – a F3500 L3 H1 (130PS) Movano Chassis Cab is type approved as Light Duty (Euro 6). Regardless of any conversion to this vehicle and even if its reference mass transgresses above the 2840kg threshold, then it is still be covered by the original Light Duty cycle emissions. One situation where this may not apply is when a vehicle changes category from N1 (Commercial) to M1 (Passenger) during the process of conversion.

COMMERCIAL VEHICLE CATEGORIES Differences between M1/N1 and M2/ N2 (Vehicles with GVW above 3500kg)

Category M: Passenger carriers Category M1: Vehicles designed and constructed for the carriage of passengers and comprising no more than eight seats in addition to the driver's seat.

Category M2: Vehicles designed and constructed for the carriage of passengers, comprising more than eight seats in addition to the driver's seat, and having a maximum mass not exceeding 5 tonnes.

Category N: Goods vehicles

Category N1: Vehicles designed and constructed for the carriage of goods and having a maximum mass not exceeding 3.5 tonnes.

Category N2: Vehicles designed and constructed for the carriage of goods and having a maximum mass exceeding 3.5 tonnes but not exceeding 12 tonnes.

Specific differences, all M2/N2 require the following:

Speed limiter: All M2/N2 vehicles are legally required to be speed limited. M2 to 62mph and N2 to 56mph.

Driver licence: Commercial vehicles with GVW greater than 3.5 tonnes have different license requirements. For any new drivers C1 category

is necessary. Under some circumstances (social purposes for a non-commercial body) it is possible to drive a minibus without a D1 entitlement (Minibus) however eligibility for this exemption should be confirmed with DVSA.

Driver CPC: Driver Certificate of Professional Competence mandates 35 hours of periodic training every 5 years to maintain licence (from September 2014).


Tachograph: It is a legal requirement to administer the activities of drivers subject to the EU or AETR drivers' hours rules, and also record the vehicle's speed, distance and time. A Smart Card is required for digital tachograph and these are available from the DVLA. The tachograph of a new vehicle must be calibrated within two weeks of first registration.


Operator's Licence: This may also be required to ensure that vehicles are kept safe and in good condition at all times. Specifically for M2, PSV (public service vehicle) operator's licence is required. Exemptions in some circumstances may be permitted but this should always be confirmed with DVSA.

MOT Testing: M2/N2 must be tested each year, and vehicle presented with a completed Certificate of Conformity (CoC). This is available from Vauxhall (regdata@gm.com) or from converter in case of second-stage conversion.






